1. A separate, \$ _____ non-refundable booking fee must be paid to Cindy C. Wilkes at On The Bit Farm when mare owner returns this contract. A copy of the mare's registration papers must be submitted with the contract if the mare is to be included in any report of mares bred for Don Alfredo.
2. Documentation. When this contract is signed and returned, On The Bit Farm will send the mare owner a Mare Identification form and a Mare Breeding Passport. The Mare Identification Form must be filled out by the Veterinarian. The Mare Identification Form must be returned to Cindy C. Wilkes before delivery of live semen. The mare owner must return the semen container (Equitainer), with the completed Insemination Certificate, by Federal Express "Standard Air" within 24 hours of receipt of the transported semen. Starting the 5th day after shipping date, a late fee of \$15 per day will be charged if not returned.
3. Pre-shipment steps. In addition to the signed contract and booking fee (see section 1), and the Mare Identification Form (see section 2), Cindy C. Wilkes must receive the \$ _____ stud fee, a \$ _____ deposit on Equitainer, and a current uterine culture (taken when the mare is in heat, submitted to a licensed laboratory) before live semen will be shipped to the mare owner. No part of the stud fee will be returned after at least one shipment is made.
4. If more than two (2) shipments of live semen are required, the mare owner will be charged \$ _____ for each collection.

5. Live Foal Guarantee. It is agreed that, under this contract, a live foal will be guaranteed from the transported semen for a maximum of two breeding seasons. A live foal is defined as a newborn foal which stands and nurses. If the foal is born dead, return privileges may be exercised by the mare owner for the following season, if Cindy C. Wilkes is notified within seventy two (72) hours from the foaling date, and receives a veterinarian's statement concerning the circumstances of death within ten (10) days of the foaling date. If the mare dies, or after examination by two licensed veterinarians, is found unfit to breed, another mare may be substituted with the consent of Cindy C. Wilkes. If the mare is examined by a licensed veterinarian and found to be barren fifty (50) to seventy (70) days from the last date of insemination, return privileges are also granted. If, after one breeding season, the mare does not conceive, the mare owner may substitute another mare with the consent of Cindy C. Wilkes. In any event, no more than two breeding seasons will be honored. The breeding season is from March 15th to September 1st.
6. Semen remains the property of On The Bit Farm and must be accounted for. It is understood that the transported semen may be used only for the mare designated on this contract, and that all excess semen must be destroyed. Should the semen be used on a mare other than the mare so designated on this contract, without Cindy C. Wilkes written permission, this contract becomes null and void, is strictly forbidden, and constitutes theft. A separate stud fee is immediately due for each embryo conceived and successfully implanted in a host mare.
7. A licensed veterinarian must examine the mare fifty (50) to seventy days after the last insemination date and advise Cindy C. Wilkes, in writing, of the mare's pregnancy status, or the live foal guarantee of this contract shall become null and void.
8. Cindy C. Wilkes, and On The Bit Farm, assumes responsibility only to deliver live semen, in viable condition at the time of delivery, to the mare owner, or his or her designee. The semen must be administered by a licensed veterinarian on the day of delivery; otherwise all conditions of this contract become null and void.
9. Should Don Alfredo die or become unfit for service, this contract is transferable to your choice of the other stallions owned by Cindy C. Wilkes at On The Bit Farm.
10. This contract must be filled out in full. The mare owner must sign and return it to Cindy C. Wilkes. When Ms. Wilkes signs and returns a copy of this contract to the mare owner, it will then be a binding contract on both parties, subject to all the above terms and conditions. This contract may not not be assigned or transferred by the mare owner.
